### ARTICLE E 7.11.9 MAXIMUM NUMBER OF LEVELS/TESTS/CLASSES PER HORSE PER DAY

- 1. A horse/rider combination may compete in any two, but only two consecutive levels and a maximum of four tests per day including the freestyle.
- 2. No horse may compete in more than four tests or rides combined per day, including the freestyle.

3. A horse may compete in any two, but only two consecutive levels and a maximum of four tests per day including the freestyle.

4. When more than one athlete competes on the same horse the horse may not compete against itself and may not compete in more than four tests or rides per day including the freestyle.

5. Equitation, Materiale and non-EC classes are included in the maximum of four classes per day.

## **GENERAL RULES AND INFORMATION**

\* All questions are to be directed to the Show Committee

\* Any riding time changes must be approved by the show secretary prior to the competition.

\* No person other than the officials, attendants, on duty and the judges of the class may enter the show ring without permission from the officials. Competitors entering the arena outside of the posted warm up times will be eliminated.

\* The Show Committee reserves the right to remove any horse/ rider from the competition without being liable for compensation.

\* There will be no test readers provided by the show, please supply your own reader.

\* Standard whip length is 120cm. (including lash) and ponies riding in ANY class can only carry a whip of 100cm. Including lash.

\* Dogs are always welcome however for safety reasons, we ask that you please keep your dog on a leash at all times. For safety and sanitary reasons, no dogs will be permitted in the schooling area, show rings or show office.

\* Riders must wear approved helmets at all times while mounted on show grounds.

\* Areas to be used for warm up/lunging will be posted.

\* Must follow Cold Lake Ag Society rules available at www.coldlakeag.com

\*AEF# or other Provincial Sport Organization # must be provided as it is required by the Cold Lake Ag Society and Alberta Wild Rose. Temporary AEF#'s will be available through Show Secretary on show day.

# AEF HELMET POLICY


For safety and insurance purposes, all riders, regardless of age or level, must wear ASTM/SEI,BSI/BS,EN or AS/NZS approved headgear AT ALL TIMES WHEN MOUNTED at any Wild Rose competition.

## **STALLIONS**

Mannerly stallions may be shown by 18 and over Adult Competitors ONLY.

## **COMPETITION NUMBER**

The competition number designated to the horse/rider combination by the Show Secretary must be worn by the horse or horse/handler from the time it is issued whenever the horse is not in its stall or trailer, in order to facilitate identification by officials. A warning will be issued the first time the horse is seen without its designated number. The second offence may result in elimination or disqualification as determined by the Ground Jury, Steward or Show Committee.
